It includes various federal, state, and utility-provider ran programs, with a particular focus on services for low-to-moderate income residents, renters, and multi-family properties.

State and Federal Programs

Low Income Housing Energy Assistance Program (LIHEAP)

Overview

The Low-Income Home Energy Assistance Program (LIHEAP) helps low-income families and individuals meet home heating and medically necessary cooling costs. An eligible household that heats with natural gas or electricity may have its benefits directly forwarded to its utility company. Otherwise, in most cases eligible households directly responsible to a fuel supplier for payment of home heating costs receive a two-party check in the name of the applicant and “the fuel supplier”. Households whose heating costs are included in their rent receive a one-party check made out to the eligible applicant.

Eligibility

You must:

- be responsible for home heating or cooling costs, either directly or included in rent
- have gross income at or below 60% of State Median Income

How to apply

- 1) Application period for 2023: October 1, 2022, to June 30, 2023.
- 2) Award period: October 1 to September 30
- 3) Download, print, and fill out the DCA’s [application form](#) and send it to a local LIHEAP/USF application agency using [this directory](#).
- 4) When you apply to LIHEAP, your application also applies to the USF (Universal Service Fund), which provides monthly credit to aid residents in paying their utility dues, in addition to a fresh start forgiveness program for those facing gas and electric arrears. [Learn more here](#).

- 5) Note: if you have received LIHEAP/USF last year and have not moved properties, you are eligible to recertify. If you are still eligible, the recertification process will begin automatically. You can fill out a [recertification application](#) and mail it, either to USFHEA-application@dca.nj.gov or physically to the agency listed on the recertification letter.

New Jersey Weatherization Assistance Program

Overview

WAP assists specific populations with weatherizing their properties, particularly elderly, disabled, and low-to-moderate income New Jersey residents. Direct assistance goes to both those living in low-income housing and the community organizations which serve them.

New Jersey SHARES

Overview

NJ SHARES provides energy assistance to moderate and fixed-income households experiencing a temporary financial crisis. Eligibility is based on household size and income. Families and individuals which earn too much to qualify for other federal and state assistance such as LIHEAP may be eligible for NJSHARES. NJSHARES grant amounts can be up to \$700 for heating source (natural gas, including cooking gas and electric heat) and up to \$700 for electric service. Grants must result in continuance and/or restoration of service. They are issued directly to the utility company on the customer's behalf.

New Jersey PAGE

Overview

Payment Assistance for Gas and Electric helps low to moderate-income families in New Jersey pay their utility bills. PAGE is administered by the Affordable Housing Alliance, with funding from the Board of Public Utilities (BPU) and is a financial assistance program designed to help households across the state of New Jersey who are experiencing economic hardship and struggling to pay their electric and natural gas bills.

Eligibility

You must:

- Be a customer of one of the seven main NJ utility providers or indirectly receive service from them through a third party
- Demonstrate your utilities are in danger of being shut off, actively being shut off, or have already been shut off; in addition to having a minimum utility account balance of \$100
- If your income is low enough to qualify for LIHEAP/USF, you must first apply to those programs before applying to PAGE
- Submit the required documents listed [HERE](#)
- Fall below the gross monthly income limits listed in this chart:

New Jersey Comfort Partners

Overview

The New Jersey Comfort Partners Program helps income-eligible customers reduce their utility bills through implementing cost effective measures which save energy and money while improving their home's safety and comfort. Installations are free for the customer and audits usually take around two to three hours.

Quick Home Energy Check Ups

Overview

Quick Home Energy Check-up Programs are no-cost in-home assessment programs, usually lasting about an hour. During the appointment an Energy Advisor will review your home's energy efficiency, provide a report with recommendations for energy-saving improvements, discuss other energy efficiency programs available to you, and may install energy-saving products, including:

ENERGY STAR® certified LED bulbs	Water heater pipe wraps
Showerhead adapters	Efficient-flow showerheads
Faucet aerators	Smart power strips

Eligibility

Must be residential customer of the relevant utility provider. Check with your provider for details.

Home Performance with ENERGY STAR®

Overview

HPwES helps homeowners improve the energy efficiency of their homes, including typically up to \$5,000 of dollars in rebates and \$15,000 in interest-free loans for energy-efficient appliances, HVAC upgrades, insulation upgrades, and improvements to health, safety, and comfort.

Eligibility

Must be residential customer of the relevant utility provider. Check with your provider for details.

Income-Qualified Weatherization

Overview

Income-Qualified Weatherization provides similar services to Comfort Partners for residential customers earning between 250% and 400% of the Federal Poverty Guidelines.

Eligibility

Check with your provider for details. You must be a residential customer of the relevant utility provider. You must also be between 250% and 400% of the Federal Poverty Guidelines, live within a moderate-income Census tract (based on this list), OR participate in one of the following safety net programs:

Multi-Family Programs

Overview

If you are a tenant in a multifamily building, you can approach your property manager and request they look into utility-based weatherization services. Most utilities provide at least two programs:

1) Multifamily Direct Install Program (MDIP):

Like the single-family Home Energy Check-Ups, MDIP provides free on-site assessment to improve energy efficiency, including but not limited to complimentary installation of faucet aerators, efficient showerheads, and LED lightbulbs.

2) Multifamily Home Performance with ENERGY STAR (MHPwES):

Like the single-family HPwES, a Building Performance Institute (BPI) certified auditor will conduct a thorough audit of the building, identifying potential upgrades with HVAC, insulation, and water heaters eligible for special financing deals up to \$1,500 per unit. Note that the auditor may sometimes charge a small fee; please check with your auditor beforehand.

Eligibility

Check with provider for details. Buildings must have the following qualifications:

SJG: At least three units, fewer than four stories tall

ETG: At least three units, fewer than four stories tall

PSE&G: At least four units

ACE: At least four units

JCP&L: At least five units

O&R: At least three market-rate units

Rebates

Overview

Rebates exist across service providers for residents and property managers alike who wish to remove aging appliances, such as washers, dryers, and fridges. However other forms of rebates exist such as:

- General Appliance Rebates
- Appliance Recycling
- HVAC Rebates
- Lighting Rebates

Eligibility

Check with your provider for details. You must be a residential customer of the relevant utility provider, and other qualifications may also apply depending on the exact program.

South Jersey Gas:

SJGC offers rebates for appliances with a particular focus on washers and dryers. Additionally, the company offers up to \$1300 for qualifying HVAC and other water heating systems.

Community Solar

Overview

Community solar is commonly defined as any solar project or purchasing program, within a geographic area, in which the benefits of a solar project flow to multiple customers such as individuals, businesses, nonprofits, and other groups. In most cases, customers receive partial power from energy generated by solar panels at an off-site array. Customers continue to receive main services through their utility provider, while receiving partial credit on their electric expenses.

Although still being serviced by their main provider, intermediary Community Solar Organizations such as [Solar Landscape](#) and [Dimension Renewable Energy](#) work with the community and all parties involved to integrate their urban solar farms into the local participating properties. Examples of these solar farms can be seen [here](#) and [here](#).

Eligibility

Check with your provider for details as areas of service can have multiple Community Solar Organizations working in specific areas. You must be a residential customer of the relevant electric utility provider, and other qualifications may also apply depending on the exact program. Glossary and Appendix

Rebate: a partial refund

Subsidize: A direct or indirect payment, typically from the government or a targeted tax cut.

Weatherization: the practice of protecting a building and its interior from the elements, particularly from sunlight, precipitation, and wind, and of modifying a building to reduce energy consumption and optimize energy efficiency.
