Ms. Bruce is a proud alumni of Howard University, Rutgers University (Cook College and Edward Bloustein School of Urban Planning), and Keller School of Management.

Prior to Treasury, Ms. Davis led the \$2.4 billion New Jersey Lottery as Executive Director and CEO and served as a senior policy advisor in the New Jersey Department of Health and Senior Services. She began her legal career as a trial litigator, is an Honors graduate of Seton Hall University and holds a Juris Doctorate from Seton Hall School of Law.

Suzanne Ghee is responsible for providing the oversight and direction for designing, implementing, and supporting a robust enterprise wide community health strategy at Virtua Health. At USICH, he helped implement the Obama administration's plan for ending chronic homelessness and homelessness among veterans by 2015; he also helped develop a national research agenda related to homelessness. From 2006 to 2011, he worked as an analyst for Abt Associates, where he was involved in numerous studies, including the Annual Homeless Assessment Report; the Costs of Homelessness study; the Study of Rents and Rent Flexibility in Subsidized Housing; and an evaluation of the AmeriCorps program. the prevention, management and revitalization of vacant and abandoned properties, now in it's second edition); *Building a Better Urban Future: New Directions for Housing Policies in Weak Market Cities*; and *Shared Equity Homeownership: The Changing Landscape Of Resale-Restricted, Owner-Occupied Housing* (the first comprehensive research on this housing sector).


